### ***Timothy J. Kennedy Memorial Moot Court Fund Established at the Indiana University School of Law-Indianapolis***

Indianapolis, Indiana. Today the Indiana University School of Law-Indianapolis, together with Mike Miller, John Muller and Tilden Mendelson, founding partners of Montross, Miller, Muller, Mendelson & Kennedy, LLP announced the establishment of the Timothy J.
